UMECRA Senior Equine Award -

Donated by Sharon Hahn
This award honors the equine 20 years of age and older that accrues the highest number of

UMECRA points + UMECRA miles during the season. The equine may compete in multiple divisions (endurance, limited distance, competitive, novice, driving) and with any number of riders. The equine must complete at least 4 rides to be eligible. Owners need to nominate their horse by sending their nomination form to Sharon Hahn accompanied by proof of age (registration papers or vet letter or other evidence for unregistered animals). There is no fee to nominate.

To qualify, complete the Senior Equine Nomination Form (available on the UMECRA website) and send it to Sharon Hahn as indicated on the form.

UMECRA Riders Choice Award

Originating in 1981 this award is presented annually at the UMECRA Convention & Awards Banquet. Members who are at the convention vote on the nominations.

The guidelines to be considered when nominating and voting for a horse for this honor are:

- A horse that has shown superior ability in its division
- A horse that has been a consistent competitor
- A horse that has shown its ability to overcome setbacks
- Any horse, for any reasons the nominator admires, and feels is a superior representative of the "Distance Horse"

Meeting officially called to order 9:06 am by Sarah Mowrer

Minutes of the March 11, 2022 meeting were approved on the IO account and published in the newsletter and website.

Treasurer Report - Deb Moe stated that UMECRA lost a few members this year but 107 new members were added from the clinics. These new members are individuals who were given a complimentary membership from attending a clinic. These individuals will be tracked to see what year they joined and what clinic they attended. There were some rides that were a few days late in debts but Deb stated all of these should be paid soon. Overall profit/loss trends were reviewed. Peggy made a motion to accept the treasurers report. Barb seconded. Treasurer's report approved.

Awards – Janette Sasena reported that Elite 8 will have the choice of a jacket or a cooler. Restricted awards will be a wearable down blanket with different colors for divisions. Review of other awards. DRAW sponsors the junior high point award but unsure how often this happens so Barb will contact DRAW to follow up. Janette stated that awards have cost \$2700 so far and may be able to come in under budget. Discussion of the first ride t-shirt form. Theresa will make sure to put it in every ride manager packet for 2023. The first ride has to be

endurance, LD or comp with a minimum of 25 miles. Drivers are included. Motion from Dr. Jennifer to include 10 mile minimum for the first time drivers to get a t-shirt. Barb seconded. Approved.

Discussion of traveling trophies. Agreed that these trophies will be kept by the secretary and put on display at convention. Discussion of number and types of awards and how to communicate these to members so they know what awards are out there and deadlines. The Shining Light Award used to have a sponsor that gave \$100 but UMECRA is now taking it over. Peggy and Janet will work on communication for these by December newsletter. Janette stated that Purina has given donations for the novice division in the past. Kim will contact the Purina representation to see if they will sponsor this award for 2022-2023.

Vet Handbook – Dr Jennifer Lorenz reviewed the current version of the handbook. She will incorporate any changes and resend out final document to the board. Reviewed veterinary ride agreement form being created for ride managers to give to vets.

Rules committee – Theresa reviewed the Rule Change Proposals.

Competitive Rides 3.B. Discussion of leg protection and hoof boots. Agreed that Version 1 will be the one presented for a vote at the convention. Motion by Theresa to accept wording. Peggy seconded. Approved.

Version 1

COMPETITIVE RIDES

3. Rider Requirements

B. Devices which serve strictly as leg protection shall be penalized two points per leg per day. Examples include, but are not limited to bell boots, splint boots, wraps, sleeves or any device that was not manufactured to hold hoof

protection in place. All types of hoof protection are permissible, including hoof boots with the manufacturer's associated parts. Boots and parts shall NOT extend above the pastern, or the boot will be subject to the two points per day per leg penalty. The judge may request to observe the area covered by the boot and/or the area under any leg protection at any time. If leg protection is not declared, see (H).

Current hoof boot rule:

COMPETITIVE RULE

3. Rider Requirements

B. If boots, bandages, or wraps are used, the horse shall be penalized two points per leg per day. Boots and their permanent attachments designed to protect the sole of the hoof are permitted, and shall not be penalized. The judges may request to observe the area covered by the attached strap, keeper or gaiter at any time. If boots are not declared, see (H).

H. The penalty for failing to follow the above requirements: completion only, miles only or disqualification. (2014)

Sanctioning Requirements UMECRA RULES 2.O. Theresa presented the changes. Linda Mowrer made a motion to approve changes in wording of sanctioning fees. Peggy seconded. Approved.

SANCTIONING REQUIREMENTS

2. UMECRA RULES

O. All sanctioning fees must be paid are due by Feb. 1st. If not paid by this date, the ride loses sanctioning for the year Sanctioning Coordinator will send an email to the ride manager (call or letter sent by confirmation delivery) and document that contact has been made requesting the funds. Late payments will be considered a re-sanctioning request and must be approved by the Board of Directors. Penalties for late payments may include: delay in the posting of the ride flyer online, exclusion of the flyer from the ride book, and loss of ride sanctioning. It is the ride

manager's duty to contact the Sanctioning Coordinator and Treasurer if their contact information has been changed from the previous year.

Endurance Rule 7. Change of midride vet checks for a 100 mile from 3 to 4. Theresa motioned to approve this as written, Linda Mowrer seconded. Approved.

ENDURANCE RULE

7. There must be a minimum of two midride vet checks on a 50-mile ride and a minimum of three four midride checks on a 100-mile ride.

Competitive Driving Rule General Rules D. Linda Jacobsen interviewed drivers and the drivers agreed that any suggested change should come from the Midwest Distance Driving Association (MDDA). Drivers can also talk to the ride manager about any concerns. Tabled.

COMPETITIVE DRIVING RULES

GENERAL RULES

D. Drivers should be started at 5 minute intervals. This may be shortened by a minute or two if number of entries exceeds 12.

Article VIII Membership Section 1 Eligibility – this be voted on by membership in January 2023. Board approved it at the March meeting.

ARTICLE VIII

MEMBERSHIP

Section 1. ELIGIBILITY. Membership in this organization shall be limited to active members only. Such active memberships shall be granted to individuals, to families and to endurance and/or competitive trail rides.

(a) All persons shall be eligible for an individual membership.

(b) Family memberships shall consist of one or more related, or coupled as significant other, adults and/or children of such adults who are less than 18 years of age, all of whom reside in the same household.

(c) Endurance and/or competitive rides shall be granted a membership on proper application approved by the Board of Directors.

(d) Each member shall abide by the rules and regulations established by the corporation.

Section 2. DUES. No endurance or competitive trail ride, individual, or family shall become an active member of this organization unless or until it/s/he shall first pay to the corporation the annual dues which shall be set by the Board of Directors from time to time.

Section 3. RIDER

REPRESENTATIVES. Individual members and family memberships of the corporation shall be entitled to vote for the four Rider Representatives who shall serve as delegates to the annual or special meetings of the corporation. Ride managers are not eligible to be elected as Rider Representatives. Family memberships shall be entitled to as many votes, up to a maximum of two votes per family membership as there are adults within the family unit.

Proposed Changes

Please take a few minutes to review the following rule changes that are being proposed for the upcoming annual meeting. The proposals will be reviewed during the meeting and voted on by the designated ride delegates.

2023 UMECRA Bylaw Change Proposal – Requires 2/3rds approval	Rationale

Family memberships shall be entitled to as many votes, up to a maximum of two votes per family membership as there are adults within the family unit.</p>	<p>Because UMECRA does not ask for member’s ages on annual member forms; a proposed change in the bylaws to match the long-time practice of allowing two votes for family members no matter if the family member is two adults or an adult and a minor member, or multiple family members of different ages. This is for Rider Representative voting.</p>

Late payments</p>	<p>The current rule for fees not paid by February 1st is very rigid, especially if fees are a few days late. The rewrite is a solution which is viewed as more workable by the board and has various penalties laid out within the new rule.</p>

<p>UMECRA ENDURANCE RULE 7. There must be a minimum of two midride vet checks on a 50-mile ride and a minimum of three four midride checks on a 100-mile ride.</p>	<p>This proposed change bumps up the number of checks required in a 100-mile ride that will match newly adopted UMECRA veterinary guidelines. It also clarifies that the checks listed here are to be midride checks, and not count the "final check" in this total. **This rule if passed will be underlined in our rule book, because it is more strict than AERC, which requires one checkpoint hold in any ride 25 miles or more.</p>
<p>UMECRA COMPETITIVE RIDE Rules – Proposed new wording for 3.B: 3. Rider Requirements B. Devices which serve strictly as leg protection shall be penalized two points per leg per day. (2014)</p>	<p>Hoof protection continues to evolve in sophistication, and the current rule has caused at least some confusion at one ride. Some boots have attachments that are designed to be changed out, so they are not permanent. A different boot may have a similar strap, and be permanent but not penalized.</p> <p>In an effort to not to discriminate against certain hoof boot brands, <u>leg protection</u> is defined and penalty points are taken. This has been the long time practice of UMECRA and other competitive trail groups. <u>Hoof protection</u> is also defined and defined what is acceptable.</p> <p>Hoof protection that extends above the pastern is either not allowed by other competitive trail organizations or it is given penalty points as described in this rule.</p>
