Trails: The course winds through the heart of the Vilas County Forest on a combination of gently rolling, non-motorized trails and on some low-standard roads that have graveled or sandy surfaces. The trail surfaces are mostly grassy. No water crossings.

Camping: Ride camp is at Pioneer Creek Ranch located at 4336 Church Road, Conover, Wisconsin. Camping is rustic in three fenced-in pastures that are fairly level to gently sloping – good for portable fencing and some opportunity to highline. There are a limited number of 12x12 corral panel pens available for rent. Contact the landowner to reserve a pen. Dogs welcome but must be leashed. Potable is water available near each pasture for human and horse consumption. Porta-johns on-site.

Vet-In: Friday at approximately 4:00 pm. Copy of negative Coggins dated within 12 months required. All vet checks will be done in camp.

Friday Night: Fundraiser Dinner at 6:00 pm to be followed by Riders Meeting at approximately 7:00 pm. Community bon-fire.

Saturday Night: Potluck at 6:00 pm followed by Awards. The main dish and table service will be furnished by ride management. Please bring a dish to pass with a serving spoon. Community bon-fire.
