Entering a Ride in Minnesota?
Attention riders who come to Minnesota distance rides - please email (perhaps enter online at mndra.com & upload your Coggins) or bring physical copy of your Coggins to leave with ride management. Minnesota has a livestock exhibition permit which our distance rides fall under. This law requires ride managers to keep Coggins records for their

original hard copy phone doesn't meet the criteria for the state of MN. RMs need an electronic copy or physical copy. Thanks in advance!

Ride Results!! Just a friendly reminder to check and double-check your ride results - and do it in a timely manner (must be within 30 days). Every member should check results after each ride they attend. Don't wait for a few months when you wonder if you're in the top 8 yet. If you see an issue – contact the RM immediately and let the pointskeeper know ASAP at Ajdavis.aussies@gmail.com. Failure to report errors within the 30-day window can result in loss of placing for that ride.

Per UMECRA Rules:

4. Rider Requirements

M. The UMECRA website: www.umecra.com, shall serve as the official process of notification of ride results and point standings. Ride results and points printed therein become official 30 days after the publication date to the website (Publication dates will be logged on the site.) Riders are responsible for checking ride results and point standings for any potential errors in a timely manner and must report any suspected errors to the Points Keeper and Ride Manager within the 30 days of the publication date. Any discrepancies in the attempts by the Points Keeper, rider and/or the Ride Manager to resolve any suspected errors must be forwarded to the UMECRA Secretary. The UMECRA Secretary will inform the Executive Board of Directors of such discrepancies. The UMECRA Board of Directors will be responsible for the

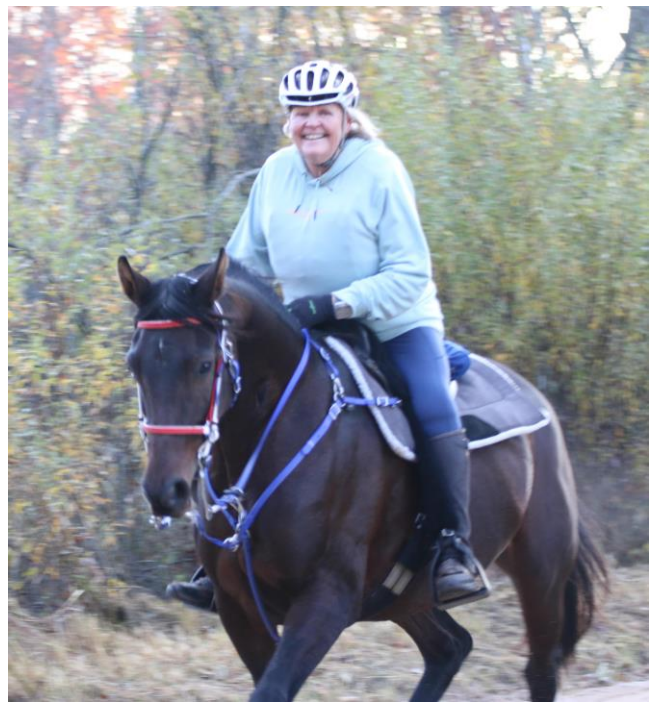
