Free SafeSport Training for Parents, Guardians and Youth

Parents/guardians and our minor athletes are encouraged to take the free training courses that are offered by the U.S. Center for SafeSport. These courses are tailored for each group. The Parent's Guide to Misconduct in Sport is a 30-minute training video that educates parents on recognizing, responding to, and preventing abuse and misconduct in your child's sport setting. You will come away equipped with information and tactics to minimize risks of harm, You will also learn what helps create a safe sport environment for your children and what resources are available for reporting.

In addition to the training module for parents/guardians, we encourage viewing The Center's webpage for Parents and Guardians. This webpage includes important topics and resources, including the Parent and Guardian's Handbook for Safer Sport. This handbook provides information and resources to help parents understand the different types of abuse and misconduct, as well as provides tools and tips for talking to their child about sexual and emotional abuse.

The U.S. Center for SafeSport also provides training modules for minor athletes.

If you are between the ages of 13-17, the Center provides a 15-minute course that is focused on bullying prevention, supporting friends who have experienced abuse or misconduct, and resources for reporting.

For those athletes between the ages of 5-12, the Center provides a 15-minute course that helps minors know the difference between discipline

and abuse and encourages them to reach out to a trusted adult when something is not right. It also stresses the importance of positive sportsmanship and having a healthy sport environment focused on fun and safety.

<u>IMPORTANT NOTE:</u> Parental consent is required for junior competitors to register for the course.

Entering a Ride in Minnesota?

Attention riders who come to Minnesota distance rides - please email (perhaps enter online at mndra.com & upload your Coggins) or bring physical copy of your Coggins to leave with ride management. Minnesota has a livestock exhibition permit which our distance rides fall under. This law requires ride managers to keep Coggins records for their equine attendees for 5 years! Showing us your original hard copy or having the file on your phone doesn't meet the criteria for the state of MN. RMs need an electronic copy or physical copy. Thanks in advance!

Ride Results!! Just a friendly reminder to check and double-check your ride results - and do it in a timely manner (must be within 30 days). Every member should check results after each ride they attend. Don't wait for a few months when you wonder if you're in the top 8 yet. If you see an issue – contact the RM immediately and let the pointskeeper know ASAP at

Ajdavis.aussies@gmail.com. Failure to report errors within the 30-day window can result in loss of placing for that ride.
